Reporting to the Laboratory Manager you will be expected to assist in the development of products according to a specified brief and follow a project through to completion via testing, PIF compilation and cosmetic portal notification whilst liaising with the NPD team to keep them up to date with the progress of the project.

As well as being experienced, you must be a self-starter and team player, must be able to work well with little supervision and exhibit team player qualities of cooperation and coordination in a fast paced busy environment.

Job Responsibilities:

- Prepare lab batches.
- Develop products against briefs.
- Enter data onto Formulation Development Database (Creativity).
- Contact suppliers for technical information and samples.
- Research into raw materials to be used within new or current products.
- Maintain records of work in lab books and keep lab books in good order.
- Carry out stability studies.

- Type up and store QC data, compile reports to be used within Product Information Files.
- Raise Purchase Orders.
- Check that formulations are correct to then issue for manufacturing purposes.
- Supervise the manufacture of batches at contract manufacturers.
- Liaise closely with the Regulatory Department to ensure compliance of products being developed.

Requirements:

- Will have a bachelor's degree in Chemistry, Cosmetic Science or a similar discipline.
- Will have strong attention to detail and ability to document and record the progress of projects.
- Experience of having worked within the Cosmetics Industry and a strong knowledge of raw materials used.
- Knowledge and experience of Cosmetic Regulation 1223/2009.
